Avalonia Achieves National Accreditation

At a time of political change, one thing is clear and consistent: Americans strongly support saving the open spaces they love. Since 1968, Avalonia Land Conservancy, Inc., has been doing just that for the people of southeastern



Connecticut and beyond. In February Avalonia achieved national recognition, joining a network of accredited land trusts recognized by the Land Trust Alliance (LTA).

Avalonia's Executive Director, Heather Milardo, said "It is an honor to receive accreditation from an esteemed organization like the LTA. We are incredibly proud of how far we have come and are looking forward to the future of, not only our land trust,

but of the communities in which we serve. As we look toward our 50th anniversary next year, it feels good to know that we are going into the next 50 years as a nationally recognized organization with a clear vision and a strong foundation."

"Accreditation demonstrates Avalonia's commitment to the best practices and standards of land conservation in perpetuity throughout its mission area of southeastern CT," said Dennis S. Main, President. "This significantly raises the bar of our level of performance as we prepare to embark on significant new acquisition and fundraising activities." Acquisitions Chair and Vice President, Sue Sutherland, said "The amazing effort required to complete the LTA application for a complex regional land trust like Avalonia truly transformed the organization."

The LTA Commission's award of accreditation signifies its confidence that Avalonia's lands will be protected forever. "It is exciting to recognize Avalonia with this distinction," said Tammara Van Ryn, Executive Director of the Commission. "Accredited land trusts are united behind strong ethical standards, ensuring the places people love will be conserved forever. Accreditation recognizes Avalonia has demonstrated sound finances, ethical conduct, responsible governance, and lasting stewardship."

Avalonia is one of 1,363 land trusts across the United States according to the most recent National Land Trust Census, released December 1, 2016 by LTA. This comprehensive report documents the achievements of accredited land trusts:

- They have steadily grown and now steward a large percentage of conservation lands and easements held by all land trusts.
- From 2010 to 2015, they protected five times more land than un-accredited land trusts
- They have stronger systems and more resources to steward and defend their conservation lands forever.
- They have, by demonstrating and documenting their commitment to professional excellence in conservation, improved the public's trust in land conservation organizations, and thereby have helped to win support for federal, state and local conservation funding measures.

Avalonia had to provide extensive documentation and undergo a comprehensive review as part of its accreditation application, an effort that involved many, many hours of work by many, many volunteers. This effort reflects our commitment as an organization to YOU, our members, donors, and supporters; as well as our commitment to preserve our lands according to the highest standards, forever.

We are YOUR land trust.

President's Update

Happy Spring to our Avalonia Family: Members, Friends and Supporters!!!! It has continued to be a very successful and exciting year for Avalonia with our formal Land Trust Alliance (LTA) accreditation announcement in February. We look forward to Avalonia being recognized at the LTA Annual event in October 2017 in Colorado.

We also look forward to honoring past donors and founders at our Avalonia Annual Meeting June 22, 2017. Along with the rest of the Annual Meeting program, we will be highlighting our evolving Acquisition and Perpetual Stewardship Capital Plan. We currently are working on an identified short term (1-5 year) potential acquisition portfolio of roughly \$7.5million of properties covering approximately 2000 acres. Given the nature of real estate negotiations, much of the detail is confidential until contracts are negotiated, approved by the Board, and signed. However, I can disclose that Avalonia has a signed contract to acquire a fantastic 409-acre parcel that lies partially in the towns of Preston, Griswold and North Stonington. This will mark the single largest fee-owned tract that Avalonia has ever procured and is an extremely important swath of the "Last Green Valley" corridor. By contrast, the next largest Preserve that Avalonia has added, the Pine Swamp Corridor, is 389 acres and is made up of a series of 6 parcels procured over several years. We also have a signed contract for an additional 86 acre environmentally rich and historically significant parcel in North Stonington. This property has nearly 2000 feet of critical riverfront.

The overall parameters of the Capital Plan include property donations, purchases, grants, and fundraising. The precise amounts are constantly in flux as grants are announced, donation pledges and amounts are received, contracts are negotiated, closings occur and new potential properties are identified. Development Committee Chair Richard Conant is heading our fundraising planning and implementation efforts and the fundraising is expected to fully fund (through our Endowment Fund) perpetual Stewardship projected costs as are being identified by the Stewardship Committee and Chair Karen Askins for all our properties and to cover any remaining matching costs for the current proposed acquisitions.

Under the guidance of Chair Mike Pernal, the Governance Committee reviewed and recommended updates for various Governance documents as appropriate including improvements to our by-laws which are being implemented by our Board. These include bringing our fiscal year into line with the calendar year which will greatly simplify our budgeting, accounting and reporting efforts. It also expands the Board in accordance with the annual self-assessment action plan to bring additional talent to the Board and staggered Board terms to bolster continuity and succession planning.

Please put June 22, 2017 on your calendar for the Annual Meeting to celebrate with us!!

Acquisition Committee Update

I'm happy to say that the Avalonia Acquisition Committee is very busy, currently working on acquiring properties in eight towns! We visit each potential acquisition and evaluate it for land and water resources, habitat value and connectivity to other preserved space among other factors. We also consider the potential cost of stewarding the land in perpetuity which can be a significant expense. A detailed assessment is made of each property with each criterion scored.

Where does the list of potential parcels for acquisition come from? In most cases, conservation-minded landowners have contacted Avalonia wishing to preserve their land, sometimes as an addition to lands already donated to Avalonia. These landowners have observed and enjoyed the wildlife and beauty of their properties for years and now want to preserve the land forever. This action speaks louder than any words about Avalonia's fifty year history of growth as the regional land trust which has been chosen to protect and steward these gifts.

Another case is when an investor wishes to divest of a parcel. The investor may make contact with a State organization such as the Connecticut Land Conservation Council (CLCC), which will refer the person to Avalonia. Avalonia enjoys a close relationship with CLCC and, with our regional mission scope, this has identified major projects slated for acquisition.

Finally, the wider Avalonia membership may propose an acquisition. It's wonderful that this large group is thinking about which lands should be preserved, cultivating landowners for years, noticing for sale signs and keeping up with local property news. This has also resulted in several significant acquisitions.

Book Alert!

Mystic: Postcard History by Jade Huguenin and Martin Smith chronicles over a century of Mystic heritage

using local antique postcards, though two cards in particular were a mystery that led them not to books for a solution- but to Avalonia. The first was a colorful 1908 portrait of three African-Americans and a white dog perched atop a rocky ledge



outside a small cave, with a nondescript white sign nailed to a tree above them, reading "BLUFFS." The caption: "The Wolfs Den, Dean's Mill Park." The second was even older- a 1901 portrait of a bulky rock formation with a trail leading to its flat surface that loomed above a still body of



water, the caption to which read "Mistuxet Rock, Mystic. Conn." Jade and Martin were aware of the former Deans Mill Park, but not of the Wolf's Den or Mistuxet Rock. After research yielded nothing in the way of documented history on

either landmark, they were directed to Avalonia steward Beth Sullivan, who immediately recognized the glacial outcrops as two distinct locations that can both be seen from Avalonia trails. After visiting and identifying the two sites, the match was confirmed, and the mystery was resolved. Thanks to Avalonia stewards' knowledge and familiarity of the natural landscapes, two historic landmarks have been rediscovered and officially catalogued in the growing documented body of history of Mystic, Connecticut. The marriage of local nature conservancy and historic research is often overlooked, but cannot be understated; the value of Avalonia's efforts to preserve Connecticut's natural environment for years to come is priceless.
